Saucon Valley Parade Committee ("SVPC), volunteers from Hellertown Borough and Lower Saucon Twp., collectively known as the "Volunteers", is holding the Annual Spirit Parade on Sunday, October 22, 2017 (the "Parade"). The Parade begins at approximately 2:00 PM and marches on Walnut Street to Main Street to Water Street to Rentzheimer Street to Durham Street to Constitution Ave. This release covers all activities from 1PM to 6PM.
2. Participation in the Parade are limited to individuals and groups who have registered in advance by completing a Participant Release Form. There is no cost to be a Participant in the Parade; not all Participants will receive a prize. SVPC must have the name, valid email address and signature of every Participant or Group Leader in order to participate in the Parade.
3. By completing the Participant Release Form, including its waiver, the Participant enters an agreement with the "Volunteers," acknowledging that SVPC shall not be responsible for any damage, loss, injury, bodily harm, or property damage resulting in any manner from attendance by Participant at the Parade or from participation by Participant in any activities related to or arising from the Parade. The Saucon Valley Parade Committee reserves the right to determine whether any applicant will be chosen to participate as a Participant and to decline any applicant for any reason.
4. Any participant under the age of 16 must be accompanied by a parent or family representative.
5. There is absolutely no setup or decorating allowed in the staging areas around the middle school and elementary school areas! Horses in the parade must either be diapered or have a designated "pooper scooper." Other animals will be approved on a one to one basis.
6. "O" Tolerance. Any participant or anyone associated with the participant must be respectful to all volunteers during staging, during parade itself and disbanding of parade. Any portion thereof will result in immediate disqualification of parade winnings and expulsion of future parades.
7. All vehicles used in the parade must have current registration.
8. Following the Parade, the Volunteers will announce the winners. The winners will be published in the newspaper and notified by mail with the winnings. Participants are responsible for all taxes associated with winning a Prize. The Sponsors make no warranties or representations about any Prize.

I hereby agree to participate in or to allow my child or pet to participate in the Saucon Valley Spirit Parade to be held on October 18, 2015. I have read the Parade Participant Rules and agree to be bound by them.
