IX. Unfinished Business

1. Discussion – Increasing the Treasurer's Bond to \$400,000

2. Discussion of Reimbursement of Towing Fee

Mr. Corriere reviewed the various Codes associated with towing a vehicle during a snow emergency and found they 1) provide the authority for the towing of vehicles and, 2) the codes do not provide a waiver provision. The Borough cannot consider a request for reimbursement of towing fees under the current ordinance.
