Mr. Corriere- The proposed ordinance would have to be advertised and sent to the Lehigh Valley Planning Commission and Hellertown Planning Commission for review. Included in the ordinance would be a safety clause to cover uses that have not been defined and make those uses a conditional use with Council approval. It also sets forth a hearing procedure. Planning Commission also recommended a Bed and Breakfast use as a permitted use in the Trail Overlay and Town Center Districts. A Bed and Breakfast would be a special exception in the Shopping Center, Mixed, and Conservation Districts.

Motion made by Philip Weber, seconded by Michael McKenna, to move forward and advertise Ordinance 805. Motion carried 6-0.

Adoption of Resolution 16-15, Appointment to Zoning Hearing Board-Council Action

Mr. Corriere- This resolution appoints Colleen Albright as alternate to the Zoning Hearing Board from January 17-December 31, 2016.

Motion made by Philip Weber, seconded by Herbert Payung, to adopt Resolution 16-15. Motion carried 6-0.

4 Discussion and Review of Section 291-6 (g) Park and Recreation Rules- Council Action

Mr. Henshaw- We received a complaint about dogs being in the park. This is the first complaint in a long time. I wouldn't pursue any action until it becomes an issue.

Chief Shupp- We have the rule to be able to enforce if there are habitual offenders.

5 Discussion on Traffic Signal Mylar for Main and High Street Signal Action

Mr. Smith- We received the signal plan for Main and High Streets intersection as part of the 412 project. There were several items that need to be addressed and I would like a representative from PennDOT to come before Council to discuss the plans since there would be a loss of on-street parking.

6. Discussion and Review of Borough Hall Kiosk Design

Mr. Rieger- We applied for a hotel tax grant for an electronic kiosk. We were awarded \$6,500.00. The total cost of the proposed kiosk is \$13,000.00. It is pedestrian oriented.

Mr. Payung- I am not for spending an additional \$6,500.00 of Borough funds. I would look for a cheaper product or additional grant funding.

Motion made by Herbert Payung, seconded by Philip Weber, to proceed with the project utilizing only grant dollars and to apply for additional grant funding to meet costs. Motion carried 5-1 (James Hill opposed).

7. Approval of Purchase and Installation of Lobby Security Camera System- Council Action

Chief Shupp- The quote that was received is from the same company that did all the wiring for the computer upgrade in the offices. The quote is for \$1,926.00.

Mr. Rieger- The cameras can be reutilized should there be any changes in the building.

Mr. Rieger noted that the funds will come from the Capital Fund.
