August 2015

This is the monthly report for the Hellertown Police Department from August 1st through August 31st, 2015.

During the month of August the Police received 442 calls for service. We did receive 10 Theft, 3 Domestic/Assault, 2 Fraud, 3 Criminal Mischief, 2 Sex Offense and 15 traffic collision calls. We wrote 131 citations.

The Police Department filed 11 charges including 4 for Narcotics Possession, 4 for DUI, 2 for Theft.

In the month of August we had our annual tent at community day which was received well. This year we had an anti-bullying theme and we handed out wrist bands, pencils, coloring books and other anti-bullying items, we also did our child fingerprint identification packets for parents.
