1. Outstanding Obligations- Approval of Payments

Motion made by Philip Weber, seconded by Earl Hill, to approve the payments with the exception of the payments to Alura which is to be held until our technology issues are resolved. Motion carried 7-0.

2. Authorization to Execute GASB 75 Proposal- Council Action

Mrs. Hartranft- The GASB 75 is required to be part of the annual audit. Now they are adding addition disclosures to be included. Beyer-Barber sent a proposal for \$7,500.00 to complete. We contacted Benecon. They are meeting with the legal team to see if it is something they can do. I would recommend Council table this matter until we hear back from them.

Motion made by Philip Weber, to table this item until we hear back from Benecon. Motion carried 7-0.

3. Authorization to Purchase Two Surveillance Cameras for the Police Department-Council Action

Chief Shupp- The police department would like to get two additional security cameras. One would be outside to view our parking area and the other would be looking at our outside door. The cost is \$1,225.00. The monthly maintenance fee is \$6.94 per month.

Mrs. Hartranft- Funds are available in the reserve.

Motion made by Philip Weber, seconded by James Hill, to approve the purchase of two additional cameras. Motion carried 7-0.

4. Review Livable Landscape Grant Award of \$21,000.00 for Saucon Rail Trail Signage Along Main Street

Mr. Smith- The Borough received a county grant to install signage to orient pedestrians to the Rail Trail or to Main Street. Signs will be installed at the trail crossings on Bachman, Water, Walnut, and Saucon Streets. Since the signage is pedestrian oriented, the

Borough does not need PennDOT approval for placement. The installation by Public Works covers the in-kind match. The rest of the funds will go toward the Water Street Project.

Motion made by Kevin Lott, seconded by Gil Stauffer, to approve the use and forward to the Saucon Rail Trail Commission for approval. Motion carried 7-0.

 Discussion on Public Works and Police Building Renovations – Council Action

Bob Korp reviewed the 2013 Space Needs Study. The study purely looked into space requirements. The new portion looked into the relocation of Public Works to the Reinhard Lot and a new two-story building for the Police Department where their lot is currently located and removing a portion of the Public Works Building. An estimates preliminary cost would be 6.2 million dollars.

The next step would be to select which alternative you want to pursue, select a design team, prepare a phasing plan, and determine financing options.

Chief Shupp- After our meetings, staff feels the first step is removing public works from the campus before any work can begin on a police department.

Mr. Heintzelman- There are possible three options that are a lot more viable than the one presented. I would like another month to complete my research and then present to Council.

Mr. Stauffer inquired as to how much money is available for the Borough to borrow.

Mrs. Hartranft- The Borough receives a borrowing base certificate yearly. The Borough would be allowed to borrow approximately 5 million dollars. Council will revisit this discussion at the first meeting in May.
