Sharon and William Feight, 25 Hampton Avenue- We live behind the new tavern and are having issues with the loud music, people speeding down the road, driving the wrong way, and the food trucks parking the wrong way using loud generators.

Mrs. Hartranft- When you have issues, please contact the non-emergency number so there is a record.

The Police will look into the call numbers and also discuss extra enforcement in the area. Council will review the noise ordinance.

VII. Reports from Elected Officials

A. President

Mr. Rieger- Mrs. Hartranft and I have been discussing the possibility of the Borough hosting an electronic recycling, shredding, or household hazardous recycling event. They County does offer partial funding but the event would have to be open to residents of the entire county.

Mrs. Hartranft- The County offers assistance up to \$3,000.00. The Borough would need to provide the site and the manpower.

Mr. Rieger- The Borough does have some funding in the Sanitation Fund that could be used should the Borough choose to cover the costs of an event.

Lower Saucon Township has expressed interest in participating if we have one. We could use the compost center cards and/or driver's licenses to check for residency.

Mr. Heintzelman offered to hold one more private event so that Council can see all that an event entails.

Staff will gather cost information and bring back to Council for further discussion.

The Chamber is looking to use Dimmick Park for their staff retreat at the end of June and is seeking a waiver of the rental fees.

Motion made by Kevin Lott, seconded by Herbert Payung, to waiver all rental fees for the retreat. Motion carried 7-0.



HELLERTOWN POLICE DEPARTMENT MONTHLY REPORT

April 2018

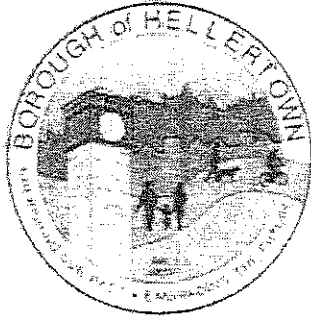
This is the monthly report for the Hellertown Police Department from April 1st through April 30th, 2018.

During the month of April the Police received 381 calls for service. We did receive 3 Theft, 5 Domestic/Assault, 1 Burglary, 1 Prostitution, 2 Motor Vehicle Theft and 9 traffic collision calls. We wrote 225 citations.

The Police Department filed 34 charges including 20 for Narcotics Possession, 2 for DUI, 2 for Theft/RSP, 1 for Forgery/Fraud and 2 for Cruelty to Animals.

In the month of April our call volume was right on par. We did have an increase in our Narcotics arrests and the guys are doing a great job in that area. We did have the case where the newborn puppies were left at HPD and we also did a fantastic job of investigating that case and making an arrest. All the puppies did survive and are with loving families. We also have recovered all of our stolen vehicles and charges are pending in that case. We had two audits and passed both with flying colors. Our first audit was from the Attorney General's Office regarding CHRIA and the second audit was done by PSP regarding NCIC. I also wanted to point out the number of citations the guys wrote, we are really trying to be proactive with traffic violations and I believe it is making a big difference how people drive through town.
