3. Award Proposal for Auditing Firm- Council Action

Mrs. Hartranft- The Borough sent out and RFP for auditing services. We received two responses: Campbell, Rappold, and Yurasits and Zelenkofske Axelrod. Both proposals were comparable. Zelenkofske Axelrod had a proposed price of \$18,500.00 and CRY had a proposed price of \$21,000.00. Auditing services are considered professional services and do not have to go out to bid.

Motion made by Philip Weber, seconded by James Hill, to use Zelenkofske Axelrod to complete the 2018 Audit as a cost of \$18,500.00. Motion carried 7-0.

Mr. Stauffer brought up a concern regarding the amount that the Treasurer's Bond covers and would like to get quotes to see about raising the coverage.

Mrs. Hartranft- The Borough code is silent regarding the amount of Treasurer's Bonds. Our insurance carrier cannot tell us how much the Borough should be bonded for. Some municipalities use 10 percent of the budget. The Borough has great internal controls in place and there is very limited exposure.

Motion made by Earl Hill, seconded by Philip Weber, to approve Resolution 19-01 and get a cost estimate for increasing the Treasurer's Bond. Motion carried 7-0.

5. Authorization to Grant PP&L Right-of-Way at Dimmick Park for a Pole and Overhead Facilities- Council Action

Mr. Smith- PP&L is looking to relocate a light at the playground area and also redirect a wire away from the new playground equipment. The new equipment will be taller than what is there currently.
