X. Unfinished Business

1. Discussion on Request for Waiver of Sidewalk and Handicap Ramp Installation at 605 Phillips Street

Mr. Russo- After the last meeting, I looked into the waiver that was granted for another house on New Jersey Avenue. The request was brought before Council and the waiver was granted due to the slope, the need to install a retaining wall, and that it would render the driveway unusable.

Mr. Fabian- The slope at the other home is seven percent. The slope at this property is ten percent.

Motion made by Earl Hill, seconded by Philip Weber, to require the installation of sidewalk and a handicap ramp on New Jersey Avenue and to grant a waiver of the sidewalk installation on Phillips Street. Motion made by 6-0.

XI. New Business

1. Outstanding Obligations- Approval of Payments

Motion made by Earl Hill, seconded by Michael McKenna, to approve the payments. Motion carried 6-0.

2. Discussion on 2021 Trick-or-Treat - Council Action

Mr. Stauffer- I asked for this to be on the agenda. When Trick-or-Treat was held on a Sunday from 4:00 p.m. to 6:00 p.m., it was a social event around the neighborhoods. Having it on Halloween in the evening takes away from the social aspect.

Mr. Rieger- The residents of Hellertown completed the survey and attended a meeting. A majority wanted Trick-or-Treat on Halloween from 6:00 p.m. to 8:00 p.m. I am not in favor of changing Trick-or-Treat.

Motion made by Gil Stauffer to move Trick-or-Treat back to the Sunday before Halloween from 4:00 p.m. to 6:00 p.m. Motion died due to a lack of a second.

3. Approval to Hold Community Yard Sale on June 5, 2021, and Waive Yard Sale Permit Fee- Council Action

Motion made by Earl Hill, seconded by Matthew Marcincin, to approve the request to hold the Community Yard Sale on June 5, 2021, and to waive the fee. Motion carried 6-0.

4. Approval to Hire YMCA to Manage Dimmick Pool and Aquatics- Council Action

Mrs. Hartranft- With Mr. Kolosky's resignation, the Borough advertised for a pool manager. We did not receive any interest. I did approach the YMCA as they run other aquatics programs in the area. They provide a manager, an assistant manager, hire the lifeguards, and get necessary certification. There will always be a manager on-site and they will test the chlorine hourly. I did receive a proposal within the typical budget. I would like to have Mr. Corriere review the legal agreement.

Motion made by Earl Hill, seconded by Michael McKenna, to accept the proposal contingent upon review by Mr. Corriere. Motion carried 6-0.

5. Authorization to Hire Sally Dartouzos as Assistant Pool Manager- Council Action

Mrs. Hartranft- Ms. Dartouzos works for the school district and has her clearances and Servesafe certificate. Staff is recommending hiring her as the assistant pool manager in charge of the refreshment stand and ticket booth.

Motion made by Michael McKenna, seconded Matthew Marcincin, to authorize the hiring of Ms. Dartouzos. Motion carried 6-0.

Mrs. Hartranft- We are still in need of applicants for pool maintenance, refreshment stand, and ticket booth.

6. Approval of Step Upgrade for Eric Cratty to Laborer I- Council Action

Motion made by Earl Hill, seconded by Matthew Marcincin, to approve the step upgrade for Eric Cratty effective March 28, 2021, per the collective bargaining agreement. Motion carried 6-0.

7. Authorization to Offer 50 30x70 Banners on Municibid- Council Action

Mrs. Hartranft- Mr. Yonney found the banners when they were cleaning out storage. We do not have room to put them up along with the Patriot Project flags.

Motion made by Gil Stauffer, seconded by Earl Hill, to place banners for bid on Municibid. Motion carried 6-0.

8. Authorization for Borough Manager to Execute Bus Shelter Agreement-Council Action

Mrs. Hartranft- Since the Borough-owned bus shelter will be placed in a PennDOT Right-of-Way, we have to enter into an agreement with PennDOT. I will need Council's approval to execute the agreement. Mr. Corriere has reviewed the agreement.

Mr. Stauffer questioned the language regarding advertising since Council seemed against any advertisement.

Mrs. Hartranft- This is a standard agreement. Any discussion regarding advertisements would have to come before Council.

Motion made by Michael McKenna, seconded by Gil Stauffer, to authorize Mrs. Hartranft to execute the bus shelter agreement. Motion carried 6-0.

9. Authorization to Award 2000 GMC Dumptruck Bid in the Amount of \$17,000.00 to Bobby Gerhart- Council Action

Motion made by Earl Hill, seconded by Matthew Marcincin, to award the bid for the 2000 GMC Dumptruck to Bobby Gerhart for \$17,000.00. Motion carried 6-0.

10. Authorization to Award Pavement Restoration and Markings Bid for Intersections of Main and High Streets, Main and Water Street, Main and Penn Streets, and Main and Walnut Streets to Marino Corp. in the Amount of \$138,985.00- Council Action

Mr. Smith- This project is a combination of two grants. This will include final pavement markings along Water and Main Streets. The other grant is for milling, overlay, and stamped crosswalks at the Main and Water Street intersection. We received one bid from Marino Corp. in the amount of \$138,985.00, which is within the budget. They are also the contractor for the Main Street Pedestrian Safety Project.

Motion made by Michael McKenna, seconded by Gil Stauffer, to award the bid to Marino Corp. in the amount of \$138,985.00. Motion carried 6-0.

11. Review and Discussion on Proposed Ordinance 836, Noise Regulations

Chief Shupp- Rather than having a noise ordinance that is open to personal interpretation, decibel readings were taken throughout the Borough at various days and times. The Police Department and Code Enforcement Officer will be provided with decibel readers. There will need to be a meeting with the Liquor Control Board to discuss this proposed ordinance.

Motion made by Gil Stauffer, seconded by Earl Hill, to authorize that advertisement of Ordinance 836 contingent upon successful meeting with the Liquor Control Board. Motion carried 6-0.
