Mrs. Hartranft- Staff has received a number of complaints regarding commercial vehicle parking along Front Street and the line of sight being obstructed. In speaking the Mr. Corriere, the Borough is not required to allow commercial parking.

Chief Shupp- It is typically three different tractor trailers. The Police Department has spoken to all of the drivers. They are only in town for short periods of time.

Mr. Earl Hill recommended making a designated tractor trailer parking space.

Mr. Rieger suggested looking into the possibility of only parking in front of commercial businesses rather than residential areas.

Chief Shupp and Mr. Russo will evaluate Front Street and present their recommendations to Council at the next meeting.
