Mr. Smith- We can take a proposal to PennDOT to install more signage regarding truck traffic or the Borough can install signage outside of the right-of-way.

Diane Bachman expressed her continued concern regarding trucks having no where to turn around if the streets are vacated.

Mr. Rieger- The signage is a staff issue and can be brought back to Council at a later date.
